TRAFFIC SAFETY

READ THE REGISTRATION INFORMATION BEFORE FILLING OUT THE FORM ON THE RIGHT.

ELIGIBILITY GUIDELINES You are eligible if you have not been convicted of a traffic violation in the preceding twelve (12) months and have not been placed on court supervision within the last four (4) years anywhere in Illinois.

You are eligible if the NO COURT APPEARANCE required box, located on the bottom portion of your ticket, has been marked.

You are NOT eligible if you were under the age of 18 at the time of the violation. You must appear in court with a parent or legal guardian to request supervision.

You are NOT eligible if you have been charged with speeding twenty-one (21) miles per hour or more over the speed limit.

WHEN YOU RECEIVE A TRAFFIC TICKET YOU HAVE FOUR OPTIONS:

- 1. PLEAD GUILTY ONLINE AND PAY ONLINE Go to www.judici.com. If you choose this option, stop here and follow the instructions online.
- 2. PLEAD GUILTY BY MAIL
 - Plead guilty using the appropriate copy of your citation. •Pay cost of citation using a money order.
 - Follow the instruction on the citation issued to vou.
- 3. PLEAD NOT GUILTY BY MAIL AND **REQUEST A TRIAL**

 Plead not guilty using the appropriate copy of your citation.

•Do not appear in court until you receive a court date.

4. APPLY FOR THE TRAFFIC SAFETY PROGRAM BY MAIL

If eligible under the Eligibility Guidelines shown herein, plead guilty and sign the "Plea of Guilty with Court Supervision" form.
Complete registration form on right.
Send completed form and payment by monour order (citation cost and class fee) to Money order (citation cost and class fee) to the Circuit Clerk in the envelope provided.
Cost of citation -\$120 for all complaints.
The class fee is \$42. If you choose to

complete the online course, there is an additional \$35 access code fee that will

be billed to you by Lake Land College. •Attend an approved 4-hour defensive driving course within 120 days of the PLEA being recorded.

 You are granted 180 day court supervision and must not receive a conviction for another traffic ticket during that supervision.

BEFORE MAILING YOUR PAYMENT/ REGISTRATION

- Make sure you print the information and it can be easily read.
- Make sure your money order is made out to the clerk of the Circuit Court and it is for the right amount.
- If you wish to receive a receipt, enclose a selfaddressed, stamped envelope.

When complete, tear it off, fold and mail in an envelope to the Circuit Clerk's office.

Your class information with the date, time and location of the class will be mailed to you by Lake Land College. If you do not receive a class confirmation within four weeks, it is your responsibility to contact the Lake Land College Traffic Safety Program.

If you cannot attend your assigned class, immediately call Lake Land College Traffic Safety Program at 217-238-8258 or email trafficsafetyprogram@

lakelandcollege.edu to reschedule. You are allowed one reschedule at no cost. After one reschedule, you will be charged \$25 for any additional classes that you reschedule.

If your mailing address changes, it is your responsibility to notify the Lake Land College Traffic Safety program. The school is not responsible for late, lost and/or undeliverable mail.

If you have a Commercial Driver's License (CDL), the Traffic Safety Program will not prevent action against your CDL.

PLEA OF GUILTY WITH COURT SUPERVISION

Read this portion carefully. Make sure you understand your responsibilities.

I am requesting that the Court place me on supervision for the enclosed traffic violation. It does not require me to appear in court.

I was not under the age of 18 on the date of the violation. If so, I have been approved by the Court to complete the Traffic Safety Program.

I understand my Traffic Safety Program fee is non-refundable if I fail to complete the class or I am found to be ineligible.

I understand that my supervision will last 180 days from the date the PLEA is recorded at the court and it requires me to receive no other convictions for additional traffic violations during this time.

In the four (4) years preceding the issue date of this ticket, I have NOT taken a a 4-hour Defensive Driving Course or been on Court Supervision anywhere in Illinois.

I understand that I am PLEADING GUILTY to the charge on this ticket, I WAIVE my right to a hearing by the court or jury and request court supervision.

I agree to complete the Traffic Safety Program within 120 days from the date the PLEA is recorded.

I understand my supervision will be summarily revoked and my guilty plea will be used to enter a conviction if:

- I am found ineligible.
- I do not complete the class within 120 days from the date the PLEA was recorded.
- I receive another traffic violation within my supervision period.
- I fail to return my certificate of completion from attendance of an out-of-area traffic safety school to Lake Land College Traffic Safety Program, if applicable.
