RESOLUTION DECLARING RESULTS OF ELECTION HELD APRIL 2, 2019

WHEREAS, on the 2nd day of April, 2019, there was held in and for Community College District No. 517, an election for the purpose of electing two Trustees to serve on the Board for a full term of six years and one Trustee to serve on the Board for an unexpired term of four years; and,

- The election held on the 2nd day of April 2019 was held in all respects as provided by law, and the returns of the election have been duly canvassed by the Coles County Clerk's office and filed with the Secretary of the Board.
