INSTRUCTIONS TO BIDDERS

PART 1 GENERAL

1.01 DEFINITIONS

- A. Lake Land College Board of Trustees will be hereafter referred to in this Specification as “LLC” and all correspondence shall be addressed to: Mike Kasdorf, Director of Facilities Planning, Lake Land College, 5001 Lake Land Blvd., Mattoon, IL 61938.
- B. A Bidder is a person or entity who submits a Bid to LLC.
- C. A Contractor is a person, persons, business, organization, or other entity entering into an agreement with LLC.
- D. Bidding Documents include the Advertisement for Bid, Instructions to Bidders, Bid Forms and supplements, specifications and Addenda.
- E. Contract Documents include any Contract forms, Specifications, Drawings, Addenda, and modifications.
- F. The Agreement is the written agreement between LLC and Contractor setting forth the obligations of the parties thereunder, including but not limited to the performance of the Work, the basis of payment and the contract time.
- G. The Work is the entire delivery, installation or construction or separately identifiable parts thereof required to be furnished under the contract documents.
- H. A Bid is a complete and properly signed proposal to provide the materials and labor for the sums stipulated therein, submitted in accordance with the Bidding Documents.
- I. The Base Bid is the sum stated in the Bid for which the Bidder offers to provide the equipment described in the Bidding Documents as the base, to which Work may be added or from which Work may be deleted for sums stated in Alternate Bids.
- J. An Alternate Bid is an amount stated in the Bid to be added to or deducted from the amount of the Base Bid if the corresponding changes in the items, as described in the Bidding Documents are executed.
- K. A Unit Price is an amount stated in the Bid as a price per unit of measurement for materials or service as described in the Bidding Documents or in the proposed Contract Documents.

1.02 DOCUMENTS

1.03 EXAMINATION OF DOCUMENTS

SECTION 002113

- A. Bidders shall examine all documents and shall inform themselves of the Work to be performed. Failure to do so will not relieve a successful bidder of his obligation to provide all materials necessary to execute the Work for the sum stated thereon.
- B. Each Bidder, by submitting his bid represents that he has read and understands the bidding documents and has informed himself of the conditions of the Work.

1.04 INTERPRETATIONS DURING BIDDING

- A. If any Bidder is in doubt as to the meaning of any part of the Bidding Documents, they may submit a written request to: Mike Kasdorf, Director of Facilities Planning, 5001 Lake Land Boulevard, Mattoon, Illinois 61938; for an interpretation of that part.
- B. Written requests for interpretations or clarifications must be made no later than ten (10) working days prior to the Bid Date specified in the Advertisement for Bids.
- C. Any interpretation or change will be made only by Addenda numbered, dated, and issued by LLC to each Bidder on record as having received a set of Bidding Documents and will be available for inspection wherever the Bidding Documents are kept available for that purpose. Lake Land College will not be responsible for any other explanations or interpretations of the Bidding Documents.

1.05 QUALIFICATION OF BIDDERS

- A. Bidders may be disqualified and their Bids not considered for any of the following specific reasons:
 - 1. Reason to believe collusion exists among Bidders.
 - 2. The Bidder being interested in any litigation against LLC.
 - 3. The Bidder being in arrears on any existing contract or having defaulted on a previous contract.
 - 4. Lack of competency as revealed by the financial statement, experience, and equipment, questionnaires, or qualification statement.
- B. If requested, a Bidder shall submit to LLC a confidential Financial Statement in a sealed envelope.

1.06 PREPARATION OF BID:

- A. No modification to the terms of these bid documents will be permitted. Any deviation shall be considered cause for disqualification.
- B. All bids must be submitted on the bid form contained herein.
- C. The Bidder shall base the bid on materials complying with the Bidding Documents, and shall list all information where the bid form requires.

SECTION 002113

- D. Bids shall not be based on discounts, rebates or other refunds unless all requirements of these Bid documents are met within the terms of the discounts, rebates or refunds.
- E. The blank spaces in the bid form shall be filled in correctly with ink or typewritten. A bid form containing an alteration or erasure of any price contained in the bid which is used in determining the lowest responsible bid shall be rejected unless the alteration or erasure is corrected as herein provided:
 - 1. An alteration or erasure must be crossed out and the correction printed in ink or typewritten adjacent to the alteration or erasure.
 - 2. The person signing the bid must initial the correction in ink.
 - 3. In the event that any price used in determining the lowest responsible bid is expressed by the Bidder in both written and numerical form, the written representation shall govern in all cases.
- F. If the bid form includes alternates, each Bidder may bid on any alternate he/she chooses provided they have the required level of proficiency with item in question.
- G. If an individual submits Bid, he or his duly authorized agent must sign his name. If a firm, association or partnership submits the Bid, the name, address and title of each member must be given, and an official or duly authorized agent must sign the Bid. Powers of attorney authorizing agents or others to sign Bids must be properly certified and must be in writing and submitted with the Bid.
- H. Bids from individuals or partnerships, if signed by an attorney-in-fact, shall have attached to the bid the power of attorney, evidencing the authority to sign the bid. If the bid is signed by any other legal entity, the authority of the person signing shall be attached to the bid.
- I. LLC assumes no responsibility and bears no liability for costs incurred by a bidder in the preparation and submittal of a bid proposal in response to this RFP.

1.07 EXEMPTION FROM SALES TAX

- A. LLC is exempted by Section Three of the Illinois Use Tax Act (Sec 3, House Bill 1610 approved July 31, 1961. IL. Rev. Stat. 1961, Chap. 120 Sec 439.3) from paying any of the taxes imposed by that act and sales to LLC are exempt by Section Two of the Illinois Retailer's Occupation Tax Act (Section 2, House Bill 1609, Approved July 31, 1961 IL. Rev. Stat. 1961, Chap. 120 Sec. 441) from any of the taxes imposed by that Act.

1.08 IDENTIFICATION AND SUBMITTAL OF BID

- A. Each bid and all papers bound and attached to it shall be placed in an envelope and securely sealed therein. The envelope shall be plainly marked with the following:
 - 1. The word "BID"

- C. Bids shall be delivered before the time set for the opening of the bids. Bids arriving by mail or otherwise after the time designated for the opening of bids will be returned unopened.
- D. No oral, telephone, facsimile or email proposals or modifications will be considered.

1.09 MODIFICATION OR WITHDRAWL OF BID

- A. A bid may not be modified after submittal. Bidders may withdraw a bid at any time before opening. A Withdrawal of a Bid must be made in writing or in person by a bidder or his duly authorized agent. If a firm, association or partnership wishes to withdraw a bid, an official or duly authorized agent must sign the written request or appear in person.
- B. Once withdrawn, the bidder must submit a new bid prior to the opening in order to be considered.
- C. No Bid may be withdrawn or modified after the Bid opening except where the award of the Contract has been delayed beyond 60 days after date of Bid.

1.10 OPENING OF BIDS

- A. The Bids submitted will be opened at the time and place stated in the Advertisement for Bids and publicly read aloud and thereafter shall remain on file with LLC.
- B. After Bids are opened, the Bids will be tabulated for comparison on the basis of the Bid prices and quantities shown on the Bids.
- C. LLC reserves the right to withhold the award of the Work for a period of 60 days from the date of the opening of Bids and no award will be made until LLC is satisfied as to the responsibilities of the low Bidders.
- D. Until final award of the Work, LLC reserves the right to reject any or all Bids or proceed to do the Work otherwise in the best interest of LLC.

1.11 EVALUATION AND CONSIDERATION OF BIDS

- A. LLC reserves the right to reject all bids or parts of bids, and to waive informalities therein.

SECTION 002113

- B. For the purpose of determining the lowest responsible bidder in the consideration of all bids submitted, LLC reserves the right to accept or reject any or all alternates in the numerical order in which they appear on the bid form.

1.12 DISQUALIFICATION OF BIDDERS

- A. Bids will not be considered if they show any omissions, additions, alterations of form, conditions not requested, unauthorized alternate Bids or irregularities of any kind. However, LLC reserves the right to waive any irregularities and to make the award in the best interest of LLC.
- B. The Bidder acknowledges the right of LLC to reject any or all Bids and to waive any informality or irregularity in any Bid received. In addition, the Bidder recognizes the right of LLC to reject a Bid if the Bidder fails to submit the data required by the Bidding Documents.
- C. For the purpose of determining the lowest responsible bidder in the consideration of all bids submitted, LLC reserves the right to accept or reject any or all alternates.

1.13 APPLICABLE LAWS

- A. All applicable state laws, municipal ordinances, and the rules and regulations of all authorities having jurisdiction over the Work shall apply throughout, and they will be deemed to be included the same as though herein written out in full.
- B. Bidder's signatures shall be construed as acceptance of and willingness to comply with all provisions of the acts of the General Assembly of the State of Illinois relating to the Department of Human Rights Act, previously the Illinois Fair Employment Practices Act, Prevailing Wage Act for workers in our area, preference to citizens of the United States and residents of the State of Illinois, and discrimination and intimidation of employees. Provisions of said acts are hereby incorporated by reference and become a part of this proposal and specification.

1.14 RECORDS:

- A. The Contractor shall maintain, for a minimum of 5 years after the completion of the Work, adequate books, records and supporting documents to verify the amounts, recipients, and uses of all disbursements of funds passing in conjunction with the Work; all books, records and supporting documents related to the Work shall be available for review and audit, and the Contractor agrees to cooperate fully with any audit conducted and to provide full access to all relevant materials.

PAYMENT PROCEDURES

PART 1 GENERAL

1.01 PAYMENTS

- A. LLC will make payment on account of the Contract as follows:
1. Upon completion of any occurrence of Bus Service, as directed in these specifications, the Contractor shall request payment in full.
 2. Payment will be made provided LLC certifies that the work meets all requirements of these specifications.
 3. The Contractor shall provide an invoice for the work which will satisfy the following:
 - 1) Itemize separate line item cost for each unit type of expense incurred.
 - 2) All forms must be typed and all sections of the forms completed.
 4. Payment will be made within 45 days of certification of work by LLC.

1.02 PAYMENTS WITHHELD

- A. LLC may withhold, or on account of subsequently discovered evidence, nullify the whole or part of any payment to such an extent as may be necessary to protect LLC from loss on account of:
1. Claims filed or reasonable evidence indicating probable filing of claims.
 2. Failure of the Contractor to make payment properly to Subcontractors for materials and/or labor.
 3. Damage to another Contractor.
- B. When the above conditions are remedied payment will be made for the amounts withheld.

CHARTER BUS SERVICE

PART 1 GENERAL

1.01 SCOPE

- A. The work under this section includes the furnishing of all equipment, labor, material, supervision and services necessary for the execution and completion of all items required to provide complete and reliable Charter Bus Service as herein specified.
- B. Provide a single, \$ per mile (\$/mi) rate for a minimum capacity thirty-three (33) passenger bus, a single, \$ per mile (\$/mi) rate for a minimum capacity forty-seven (47) passenger bus, and a single, \$ per mile (\$/mi) rate for a minimum capacity fifty-five (55) passenger bus. See bid form.
- C. The term of this agreement shall be one (1) year, commencing on September 1, 2009 and shall terminate on August 31, 2010.
- D. Finalized athletic schedules for the current year are attached. Some schedules are not finalized as of this date and are provided for reference only. Finalized schedules shall be provided as they become available. Two spring 2009 schedules are included for reference only.
- E. If a Bidder is unable to comply with any of the following specifications, the Bidder shall submit in writing the reason for noncompliance. Noncompliance with any specification is grounds for rejection of the entire bid. The buyer reserves the right to reject any bid which does not meet these specifications.
- F. **Bids shall include all costs, fees, licenses, equipment, drivers, services, insurance, fuel, tolls, etc.** and shall have no hidden costs. LLC will not incur any additional cost above the Contractor's Bid price.

1.02 RELATED DOCUMENTS:

- A. All provisions of the Specifications apply to the work of this section.

1.03 SUBMITTALS:

- A. Submit for review Certificates of Insurance showing levels of coverage suitable for service as herein specified.
- B. Provide your cancellation policy and associated fees.
- C. Submit for approval; example photos or brochures as are available to properly illustrate the appearance and type of vehicles proposed to provide LLC with ample information to make an informed decision on proposed services.

- D. Provide inventory of vehicles intended for use under this Agreement. Inventory shall include year, make, condition and attributes for each vehicle.
- E. Provide

1.04 QUALITY ASSURANCE:

- A. Provide three (3) references of comparable services provided within the last three years with complete contact information.

PART 2 PRODUCTS

2.01 MATERIALS

- A. Vehicles provided shall be clean and in good working order.
- B. Vehicles shall have passenger capacity according to LLC needs and shall be adequate to comfortably accommodate all passengers and equipment as is necessary for their intended activity or sport. All vehicles sizes shall be confirmed, in advance, with the Athletic Director's office or other group requesting service.
- C. Buses shall be equipped with restrooms, heat, and air conditioning and shall be in excellent condition, with no more than seven years in service.
- D. All buses shall have under the bus storage/baggage compartments with locks.
- E. All buses shall have the ability to show videos or DVDs.

PART 3 EXECUTION

3.01 LLC SHALL:

- A. Provide overnight accommodations and meals for drivers.
- B. Pay all parking fees.

3.02 BUS SERVICE SHALL

- A. Provide Bus Service from a single loading location to the unloading area(s) of the specified event and return service to a single location as directed by the LLC Athletic Director's office. **Per mile rates shall begin at the point of loading and shall terminate at final unloading.**
- B. Travel will be as indicated on the attached schedules. Some trips require overnight stays. In most cases, teams will stop for meals when traveling to and from the destinations listed.
- C. LLC Athletics department schedules may change due to weather or other unforeseen circumstances. LLC reserves the right to reduce or cancel the required number of

buses. LLC shall notify all parties involved as soon as possible. LLC reserves the right to reschedule a canceled trip. In the event the Contractor awarded this contract cannot provide transportation on the reschedule date, LLC shall be free to obtain service outside of this contract.

- D. Service shall be flexible, including the ability to change itinerary if necessary, adding up to 60 total miles or 2 hours in time.
- E. Drivers shall be professional, courteous, and shall provide excellent customer service.
- F. Drivers utilized by the Contractor under this agreement shall be capable of understanding, speaking, reading and writing the English language.
- G. The Contractor shall certify that all its drivers are in possession of a valid driver's license qualifying them to operate the vehicles outlined in this Request for Proposal.
- H. Drivers shall be appropriately trained and regularly evaluated for conformance with safety regulations and skills in conformance with all applicable Illinois and federal regulations.
- I. If more than one (1) driver per bus is needed based on the travel distance to any destination, it is the Contractor's responsibility to determine this need and to include the cost in the Bid.
- J. The driver shall be available for contact at any time during the trip. Every bus provided by the contractor shall have a functioning cell phone with each driver at all times.
- K. Drivers shall ensure vehicles and contents are secure at all times.
- L. Bidders shall use only their company owned or leased buses. No trips can be subcontracted to another bus company or individual without prior approval of the LLC Athletic Director.
- M. Contractor shall have emergency and critical incident procedures, arrangements and personnel in place to protect passengers and minimize disruption from on road incidents, vehicle and/or system failures.
- N. In case of emergency, the Contractor should provide a list of primary and a secondary point of contact names and phone numbers.
- O. In the event of mechanical malfunctions or breakdowns, the Contractor shall be responsible for providing replacement transportation to ensure a timely arrival at specified destinations.
- P. Any backup or replacement buses used shall meet the same criteria as originally required in these specifications.

SECTION 500000

- Q. The cost of the replacement transportation, mechanical repairs, or towing service shall be the responsibility of the Contractor.
- R. The Contractor shall be responsible for compliance with all DOT/FHWA regulations with regard to their service to LLC.
- S. All charter buses provided for the scheduled trip shall be in good condition and meet all Department of Transportation Federal Highway Administration rules, regulations and guidelines. All maintenance records for buses to be provided shall be available to LLC for inspection.
- T. If an inspection of a vehicle is requested by LLC, the inspection should take place within ten (10) working days of request. Records for all vehicles used in the execution of this agreement shall be with the bus or buses at the time of the inspection. Failure to provide these records will eliminate your bid from consideration.
