MAINTAINING FINANCIAL AID ELIGIBILITY

WHAT IS SAP?

Satisfactory Academic Progress (SAP) standards are federal regulations that require us to monitor your progress toward the completion of your degree or certificate.

Three elements are evaluated at the end of each semester and are used to determine your future financial aid eligibility. This includes:

- Grade Point Average (GPA): This is a cumulative average of all coursework at Lake Land College. You must maintain a cumulative GPA of 2.0 or above.
- Completion Rate (Pace): You must successfully complete at least 67% of all attempted courses while at Lake Land College.
- Maximum Time Frame: You may not receive financial aid beyond 150% of the semester hours required for your current program of study.

YOU SHOULD MONITOR YOUR SAP STATUS IN YOUR LAKER HUB EACH SEMESTER.
